Governor Membership, Vacancies and Attendance

The Instrument of Government allows for 11 governors across different categories.

The Structure of Governance

The Board uses the circle model and has met as a Full Board 8 times this year.

The Governing Body has a continued oversight of the school's safeguarding responsibilities and manages the updates of school policies aligned to the particular areas of responsibility.

In addition to the above, the school also constitutes a Pay Committee and Headteacher Performance Management Panel annually.

Committees related to particular purposes such as dealing with complaints or exclusions are constituted as they are required, in line with the determining policy guidance.



Impact of the work of the Full Governing Body

Over the course of the last academic year, the Governing Body has demonstrated notable impact with regard to;

- Appointment of Headteacher and oversight of appointment of Deputy Headteacher
- Detailed review and setting of budget with a falling role
- Working with SLT to manage a continuing review of the class structure

The main challenges faced and addressed by the Board this year have been;

- Falling role and consequential effect on budget
- Significant mobility of new starters to the school, particularly from overseas
- Ongoing building maintenance
