## Parent / Carer

#### To help keep my child safe. I understand that:

I am responsible for checking the fitness of my child to attend School;

If my child, or anyone in my household/support bubble, shows symptoms of COVID-19, I will not send them to school and will follow isolation and testing procedures;

If my child shows symptoms of COVID-19 at school or makes the School aware of a household member who is, I will collect them from school immediately and follow isolation and testing procedures;

If I am dropping off and collecting my child, I will adhere to social distancing rules and only use the designated gates/doors and times for my child's bubble. I will pass on these arrangements to any childcare provider who may be doing this on my behalf;

If using a childminder / other provision out of school it is my responsibility to read the UK Government <u>guidance</u> and check that they are COVID Secure;

If my child is walking themselves to school, I will remind them of their access route and time, and the need to walk only with those from their year group or household;

My child will not bring any items into school with them or take items home from school (reading book/record, coat, water bottle and packed lunch are permitted):

I will not be allowed into the school without a prearranged appointment and understand that Reception is only open for urgent enquiries;

I will read all letters/messages/emails that are sent home;

I understand that if my child is deemed unsafe, he/she will be sent home and cannot return to school until they can be safe;
